## 1 OUR PROMISE

The Directors of Ironstone Asset Management Ltd have overall responsibility for implementing, monitoring compliance with and effectiveness of this Policy. The Directors of Ironstone Asset Management Ltd set a tone from the top that encourages staff to speak out if the policy is breached.

### 2 OUR PRINCIPLES

- 2. We do not engage in bribery or corruption, fraud, tax evasion, market abuse or money laundering.
- 3. We only offer and accept gifts and hospitality if they are offered transparently and legitimately, and are appropriate, infrequent and legal.
- 4. We do not act for personal gain in conflict with business interests.
- 5. We do not take advantage of confidential, inside information to make profits or undermine fair and healthy trading of shares.
- 6. We do not make unauthorised or inappropriate disclosures of the Company's confidential information and we always handle personal data with care.
- 7. We ensure all business information is appropriately managed and protected.
- 8. We do not accept the use of slavery or human trafficking in our operations or supply chain.
- 9. We have a zero-tolerance approach to any form of bullying, harassment or act of discrimination.
- 10. We develop relationships with our customers and suppliers based on honesty, fairness and mutual trust.
